- Operates hand tools, small power tools and other equipment including, but not limited to: mowers, string trimmers, chainsaws, tractors and UTV mounted sprayers
- Performs noxious weed management practices such as applying a variety of herbicides and other chemical agents, hand pulling, mowing.
- Assists in the maintenance of natural and soft surface trails
- Communicates and cooperates effectively with other parks operations employees in support of other related departmental operations such as wildlife management
- · Assists in the guidance and monitoring of seasonal employees and volunteers
- Train other employees on the safe use of a variety of small equipment
- Works outdoors in all types of weather conditions
- Removes trash and debris from Open Space
