POSITION OVERVIEW

The Southern Rockies Seed Network seeks a full-time director to guide the future of this program and to manage current programs. Established in 2014, the seed network provides an exciting opportunity for professional growth and to work among a diverse range of federal, state, and local partners and industry representatives working to create a sustainable solution to native plant materials development for the restoration industry in the Southern Rockies Ecoregion. This position will oversee the plant materials collection program, manage all fundraising activities, assist with our ecological restoration training program, develop and expand our growers' network, manage diverse mapping and data management needs, enhance and manage our marketing and outreach program, and manage the plant materials program coordinator in order to address goals and strategies outlined in the SRSN Operations Plan.

ORGANIZATIONAL BACKGROUND
