POSITION OVERVIEW

AloTerra Restoration Services, LLC (AloTerra) is seeking a restoration projects supervisor (AKA superintendent) to supervise job sites, professional crews, oversee a variety of subcontractors, perform technical interpretation of design plans, ensure production and quality results, manage project budgets and scopes of work, and perform other field and office duties for a wide range of ecological restoration projects. Projects are diverse and include river and riparian restoration, wetland mitigation, upland restoration, and erosion control for Federal, State, local, and private clients. The supervisor must excel in understanding a great variety of technical plans and communicating technical details to people with various learning styles. The successful candidate will have a strong background in restoration work, implementing project tasks such as seeding, installing container stock, willow cuttings, erosion control, mulching, and bioengineering element such as fascines and soil lifts. Experience with irrigation, applying soil amendments, and other restoration treatments is also imperative. The Supervisor must have proven experience in expert communication, job site management, conflict resolution, project budgeting, project scheduling, staff management, materials acquisition, and similar professional-level qualifications necessary to excel in this position. The Supervisor is a key member of AloTerra's dynamic project teams and is expected to provide fundamental leadership in nearly all facets of AloTerra's construction projects, including equipment operation, crew management, site safety, quality assurance, incident reporting, and more.

- Minimum of 2 years of experience overseeing crews, supervising job sites, and implementing restoration or similar projects with a high level of responsibility;
- Demonstrated ability to provide highly effective and professional communication to a broad range of people, including staff, subcontractors, vendors, and clients (local coalitions, land management agencies, private land owners, ranchers, etc.) both in writing and verbally;
- Proficient with computers, basic office related software (MS office, spreadsheets, word processing, etc.), and some advanced software (GIS, Databases, and similar); with some technical writing experience;
- Experience successfully implementing seeding, container stock, willow cuttings, erosion matting, irrigation, mulching, bioengineering, and other restoration treatments to a high standard;
- Proven ability to work with grace and professionalism under high stress situations;
- Solutions-oriented attitude, with a desire and proven ability to meet or exceed production targets, quality, and project deadlines;
- Strong desire and ability to perform physically demanding work in an outdoor setting.
- Strong organizational skills;
- Proven ability to work well as part of a team and lead crews in a manner that inspires and ensures high performance (quality, production, deadlines) under challenging field conditions;
- Clean driver's license and ability to work well in a drug-free environment; and
- Strong work ethic, energetic, and self-directed.
