**Summary:** Assist the Community Relations Coordinator with marketing and communications including social media, signage, photo and video production, fundraising projects, and public relations projects. Some remote work possible. Potential for year-round promotion in the fall.

Essential Functions & Responsibilities:

- Assists with Greenwood Wildlife's social media interaction: liking, sharing and retweeting, following new accounts, and responding to comments.
- Builds social content calendars for use on all social channels.
- Reviews social posts' success and provides metrics, insights, and recommendations for future progress.
- Works with the Community Relations Coordinator to coordinate and write copy for Greenwood's social media using Hootsuite. Brainstorms new content and campaigns.
- Designs social media graphics via Canva or Adobe programs.
- Assists with copywriting for marketing materials for web, email, and other channels as needed.
- Writes 1 2 stories/blog posts per week to be shared on Greenwood's website and social media.
- Researches articles, resources, and other content that is relevant to Greenwood's brand.
- Assists with filming projects.

Supports various fundraising events and their marketing efforts. ## **Required Qualifications**

- Strong demonstrated knowledge of digital media and communications, including proficiency in Facebook, Instagram, Twitter and other social media platforms.
- Proficiency with Microsoft Office Suite.
- Highly skilled in writing engaging and informational copy.

- Some knowledge of DSLR cameras.
- Basic graphic design skills.
- Some knowledge/experience with wildlife/environmental communications.
- Creative thinker.

#### Working Conditions

Work is performed in a wildlife rehabilitation center and shared office. Occasional remote work permitted. Potential exposure to cleaning agents, wild animals, and zoonotic diseases. Shift requires frequent standing, walking, bending, and lifting (daily up to 10 lbs. and occasionally 40 lbs.). Required to sit at a desk and use computer keyboard for most work shifts.

#### Schedule

Regularly work at least two weekdays during normal business hours. Holiday, evening, and weekend hours may be required to ensure social media comments, messages, and inquiries are answered.

Compensation: Colorado minimum wage - \$12.56
