

Mountain Area Land Trust Director of Philanthropy

Mountain Area Land Trust (MALT)* seeks a professional, energetic, articulate and experienced person to become its Director of Philanthropy. The Director of Philanthropy is responsible for leading the planning, design, implementation and evaluation of all aspects of the organization's fundraising.

MALT's philanthropic philosophy is based on stewardship and cultivation of strong, longterm relationships to sustain the organization's operations, with particular emphasis on major and planned gifts from individuals, foundations and corporations, as well as grants, special campaigns and outreach and fundraising events.

Reporting to the Executive Director, the Director of Philanthropy will be a key member of MALT's leadership team, working collaboratively to help the organization achieve its mission. This is a part-time, 28-hour a week position; salary range is \$50,000 - \$60,000 commensurate with qualifications and experience. MALT offers paid vacation, holidays, sick leave and retirement benefits.

Duties & Responsibilities

• **General Fundraising** - Working with the Executive Director, the Director of Philanthropy will direct and manage fundraising, grant and membership

development activities and annually create and execute a comprehensive fundraising plan that is consistent with the organization's budget.

- **Membership** Retain, manage and increase donor base.
- **Business** Research, secure and cultivate corporate sponsorships.
- **Major Donor** Research and meet regularly with potential major donors to develop relationships that will lead to significant gifts.
- **Planned Giving** Cultivates and manage a robust planned giving program.
- Grants Research funding sources, writes and manages grants; meets regularly with representatives of granting organizations/foundations to develop lasting and financially successful relationships.
- **Events** Manage fundraising events to improve and enhance revenue.
- Board Work closely with the Development and Marketing Committee of the MALT Board of Directors to execute a successful fundraising plan. Develop strong relationships with all Board members as a means to facilitate and open new funding opportunities.
- **Outreach** Represent MALT in the community as a spokesperson; collaborate with staff to create and implement education and outreach programs.
- Writing Skills Demonstrated, strong and successful writing skills.

- Goal and results oriented; organized, personally accountable and driven to success.
