Position Overview: The Land Management Technician plays a crucial role in promoting native plant flora in Colorado by controlling the spread of invasive plant species. This position will work with a small field crew to implement pesticide application techniques across diverse landscapes, including forested, rangeland, and residential areas. In the field, technicians utilize a range of equipment, including backpack sprayers, ATVs, and UTVs, to conduct weed control operations on both public and private lands across the Colorado Front Range. Technicians work under the guidance of a crew leader who is experienced in pesticide application, first aid, and safety protocols. This position is based out of Loveland, CO.

Travel: Personal transportation to and from Loveland office meeting point is required. Transportation to work sites is provided. Occasional out-of-town work (within Colorado) involving overnight stays is expected. Lodging and travel stipend are provided.

Position Requirements:

- Experience or interest in plant ID, plant biology, or natural resources management
- Experience operating large equipment or machinery, such as trucks, trailers, ATVs, UTVs, or spray equipment
- Experience or interest in vegetation management involving the handling and use of pesticides
- Ability to efficiently complete tasks both independently and on a team
- Commitment to the safety of themselves and others
- Mandatory utilization of provided Personal Protective Equipment (PPE)
- Possession of, or ability to obtain, a Colorado Pesticide Applicators license (testing and licensing fees are covered)
- Possession of a valid driver's license
