

# Playa Lakes Joint Venture Business Administrator

### **Position Summary**

Playa Lakes Joint Venture (PLJV) is seeking an experienced Business Administrator to support the essential accounting and operations functions of its business. PLJV is a non-profit organization with a mission to conserve the playas, prairies, and landscapes of the western Great Plains through partnerships for the benefit of birds, other wildlife, and people. This position will assist the Business Director in accounting, billing, and reporting for federal and non-federal sources of funding, and will work with the Coordinator, PLJV staff, and various partners in meeting day-to-day operations needs. Primary duties include mail collection and distribution, bank deposits, check writing, expense and receipt tracking, time tracking, onboarding support for new positions, and logistics management for board meetings and staff retreats.

- Time and expense tracking for major grants
- Accounts payable and receivable
- Office, vendor, and meeting management

## **Required Qualifications**

- Bachelor's degree from an accredited university with emphasis in business administration, accounting or non-profit management, or the equivalent in education and experience
- High level of proficiency with Google Sheets and/or Microsoft Excel spreadsheets
- High level of proficiency with Quickbooks accounting software

## **Additional Desired Qualifications**

- Excellent writing skills with proven ability to translate complex financial data for a variety of audiences
- Proven ability to manage multiple projects with conflicting deadlines
- Proficiency in Google Workspace applications
- Excellent interpersonal communication skills

### **About Playa Lakes Joint Venture**

PLJV is a regional partnership of federal and state wildlife agencies, conservation groups and private industry dedicated to conserving bird habitat throughout portions of Colorado, Kansas, Nebraska, New Mexico, Oklahoma and Texas. Our mission is to conserve the playas, prairies and landscapes of the western Great Plains through partnerships for the benefit of birds, other wildlife, and people. The Joint Venture facilitates cooperation among a broad coalition of partners on the national, regional, state and local levels to fund and implement habitat conservation. We provide regional planning, value-added efficiency and implementation approaches, while our partners provide financial, technical and local expertise to develop conservation projects. In addition, PLJV supports local conservation partnerships, state agencies and other partners by developing various decision support tools, as well as providing education about how to use the tools to target and deliver the most effective habitat conservation. PLJV also works with a variety of partners to inform landowners about conservation programs and to target conservation efforts in areas that will provide the most benefit.

### Supervisor

This position reports directly to and is evaluated by the PLJV Business Director. Job performance is reviewed in the context of responsiveness to objectives and priorities as determined by the Business Director and Coordinator. Annual work plans for the position will be developed by the Business Director in consultation with the Coordinator.

### Salary, Benefits, and Start Date

Starting salary is commensurate with education, experience, and location with an expected range of \$60,000-\$70,000 per year. PLJV offers a generous benefits package, including employer-paid health coverage (medical, dental and vision), HSA with annual contribution to defray medical deductibles, and a 7% match on salary toward our retirement plan. We anticipate this position will begin working on or around May 1.
